### **GOOD OF THE LEGION:**

Commander Nelson brought **Tracy Golliday-Champagne** forward to share information about the new Veterans Center in Pontiac. Provide counseling services to combat veterans. Located at 4200 Woodward Ave. Opened in September 2009. Providing PTSD Counseling, bereavement groups, family counseling, "We want to get the word out" – no need to go to Detroit. Services at the center are free to all combat vets, can also point toward the right people for whatever they need. Across from St Joseph Hospital – Lexus building.

**Janoska:** How many vets has the center handled so far. **Tracy:** So Far about 20. Seven vets in PTSD **Bonnie:** If you have Detroit vetrs, what do the have to do to transfer **Tracy:** Just walk in.

**Bonnie:** Do you have service officers? **Tracy:** No but we are an entity of the VA, we are our own separate entity – you have to sign a release to provide information.

**John R:** Do you need a DD-214? **Tracy:** If you don't have paperwork we can help.

Bonnie: Do you do education services Tracy: No but we will point toward the right office.

**Commander:** Do you have a list of VSO's? **Tracy:** No **Commander:** We can help you get that information so you can tell the veterans who come to you that Veteran Service Groups exist and can help in many ways (American Legion, VFW, Marine Corps League, etc)

**Bonnie:** What about homeless vets. – Bonnie to provide her contact info to Tracy

**Tracy:** Detroit has this and we will point them to Detroit.

**Bonnie:** Are you licensed **Tracy:** Yes, we have various certifications and licenses.

**John M:** We should probably put the link on the post web site

**Bonnie:** Where does funding come from **Tracy:** We get it from VA

Motion by Bob Janoska to remove Mike Allen as an officer / Executive Committee member. Motion supported by Hayden. The motion passed by voice vote. Commander Nelson will make a nomination to fill the position in the next few months.
