This was presented to General Membership for a vote at the June 21, 2016, meeting, and was passed via voice vote. Judge Advocate Neff prepared letters to Mr. Russell and the Village of Milford and shared same with the Board. Dobransky made a motion to accept the letters as written, second by Colegrove. Correction: A typo in the mailing address to the Township of Milford needs to be corrected. Neff will do. No discussion. Voice vote passes.

Officer installation is to occur by the 18th District at the General membership meeting of July 19, 2016. Commander Stevens advised this is on their schedule to occur at our next General membership meeting.

A letter has been prepared to solicit area veterans, within an 11-mile radius, belonging to Department Post 225, to transfer their membership to Post 216. E. Merritt to report to General membership as to the status of this project at the July 19, 2016, meeting.

Commander Cherf advised the raffle tickets are in to likely roll the next raffle out starting in September. A mass mailing will occur to help distribute the tickets for purchase.

We need another signee on the Bingo checks available in the absence of Ray Williams and Mike McDonnell. Gary Dykstra agreed to be this person. Ray will go with Gary to the bank to witness this signature process.

New Business: E. Merritt is looking to provide welcome pins to new members. It is suggested the pins would be provided only to new members that attend Post meetings and activities, due to cost constraints. E. Merritt to bring this topic up to membership for a motion to purchase some pins, available through Flag & Emblem.

In regards to the cannon repair needs, Ron McCall advises a bracket can be made to slightly lift the cannon off the ground, as the current wheels are in dis-repair.

Ron McCall has new markings to be placed on the tank.

We will have Post volunteers man the parking lot on August 12-14 to park cars during Milford Memories at a cost of \$10 per car. General logistics were discussed.

The Poppy drive was discussed, and clarifications were agreed upon as to the handling of incoming donations. This was the best Poppy fund drive that anyone at this meeting could recall. A coordination between the Legion and the Auxiliary will occur related to the deposit of incoming donations promptly.

Joe Bishop advises the local chapter of the DAV will be meeting at the Post, initially in Club Room, but if membership increases, then in the hall, with the hall being donated, as previously agreed upon by General membership.

SAL golf outing is August 21, and we should make a motion at the General membership meeting to support a hole at a cost of \$100. Proceeds go to Wilwin Lodge.

The Post sent two delegates to the Department convention, and we should receive a briefing from them as to what took place, at the next General membership meeting.

Per C. Merritt, October 22 is the Auxiliary Halloween dance, more Legion members in attendance is requested.
