Reports of Officers:

Sr. Vice Commander: Schimetz. No report. **Jr. Vice Commander:** Guest. No report.

Finance Officer: Williams. Excused, but provided the following report via email. For the period ended December 31, 2015, total income was \$32,707; Cost of Goods Sold \$19,568; Gross Profit \$13,139; Expenses \$8,783; Net Income = \$4,356. YTD net income \$24,204. General Fund balance = \$27,179; Special (poppy) Fund balance = \$7,095. All December bills received have been paid to date. Also, the Post is projecting upcoming liabilities of \$4,500 to include an un-yet paid \$1,000 awarded scholarship, pending the student coming to one of our meetings; the upcoming raffle to pay out \$1,000; and \$2,500 for hall renovation work. We ended the fiscal year of 2015 with an impressive net income of \$24,204, as compared to 2014 = \$2,717; and 2013 = \$7,711. This report has been submitted subject to future audit.

Chaplain: T. Kemper. Advises Paul Lehr's cancer has returned, thoughts and prayers go out to Paul. Also, Post member Daniel Larkin had a successful by-pass operation, prayers for a speedy recovery. Also met with Past Chaplain, Archie Noon, and he is doing well.

Service Officer: Reddeman. Absent. No report.

Historian: Vacant. No report.

Adjutant: Hungerford for Dobransky. No report.

Auxiliary: Cathy Merritt. Again requesting Post members to save plastic bags needed for the making of sleeping mats for homeless veterans. There is a collection bag in the Club Room near the door.

SAL: McDonnell. Hamburger night every Thursday from 5-8pm.

Motion by Salvia to suspend the regular meeting to hear from guests Chris Walters and Marty Cook, related to the annual fish fry at the Post; second by Neff. No discussion. Voice vote passes. Chris advised they are again volunteering to work a weekly fish fry, starting on Friday, February 12, 2016, running each Friday through Lent. Last year this created income to the Post for about \$3,000 after start-up expenses. Is making a request for the Post to again provide the start-up cost of \$500.

Riders are holding a chili cook-off on Saturday, March 19. The Riders donated \$1,698 toward veteran related events during 2015. ROLLING MINUTES (Used to capture significant agreements and/or votes of a permanent nature unless later eliminated or changed by membership or the Executive Committee as is allowed). This document will form a part of each monthly meeting minutes to be used for quick reference as may be needed.

- The Post Commander is granted \$250 in discretionary expense spending per transaction. (From June 16, 2015, General Membership meeting minutes).
- Emergency expense funding, such as the breakdown of the building furnace or A/C unit. As long as the Club Room manager, or the building chairperson, contact the board to advise of the emergency situation, then the emergency funding will be authorized. This is different than say the cost to resurface the parking lot, which is not an emergency situation that would be presented to General Membership for review and approval. (From June 16, 2015, General Membership meeting minutes).
- A policy has been implemented that any person that financially obligates the Post for nonemergency related expenses, aside from the Commander's \$250 discretionary expense authorization, without the prior consent of the general membership, can be held personally liable for the expense. (From July 14, 2015, Executive Committee meeting minutes).
- A policy has been implemented putting newly elected officers in place immediately following the general membership meeting held on the day of the annual election of officers. (From July 14, 2015, Executive Committee meeting minutes).
