Review of minutes from 18 June, 2013. Motion to accept, First Reddeman, Second Merritt. No corrections, no discussion. Voice vote passes.

Agenda Items: Commander Puente brought to our attention a Hometown Hero advertising billboard that promotes local businesses, and is seeking to have the billboards posted in the club room. No cost to the Post. Advertisers pay to have their business promoted.

Commander Puente read a letter from Joseph Salvia, Commander, Huron Valley AMVETS, Post 2006, that they have decided to move their monthly meetings to another facility to better accommodate their membership. Loss to Post revenue of \$50 per month plus income from Club Room sales.

Good of Legion: It was mentioned that a request has been made to donate (4) hours of hall use for Tim Burns' son, a local Boy Scout member, so he can hold his Eagle Scout court of honor ceremony. We have (3) scout troops related to the Post.

Norm Tibbs advised the Post has 15 plots left at the Oakgrove Cemetery located in block 12, plots 17-40, for use by Veterans in need, at no cost to the Veteran. Information regarding these plots is maintained at the Milford Township office.

Old Business: Commander Puente to check into the deeds for plots at Oakgrove Cemetery. Also, need to update status of Parade fund net income to the General fund.

Status of the internal finance audit committee? This was to have been completed by two weeks from this meeting. In addition, Commander Puente revisited the need for a formal external financial audit. Ray advises an outside auditor would cost about \$500. Reddeman agrees this is necessary.

Finance Report: Williams. Advises due to computer issues, does not have the consolidated reports. But June is looking good. We are receiving income net of expenses from the Parade fund of about \$3,000 to the General fund. Ray mentioned we are low on Veteran medals for next year, and we will need to make a purchase of more medals. Also, received a contract from Flag Poles for \$625 to renew the annual service. Signature needed to renew the contract, and Dobransky signed same. About \$1,400 in expenses to pay this month still, but a check from Bingo for \$1,500 coming in, plus the Parade fund money, so we are doing good.

Dobransky mentioned the need to complete an internal self-audit of the Post financial records, for submission to Department. It was agreed a committee would be formed, headed by Norm Tibbs, with committee members Bill Colegrove and Jack Winder. Mike McDonnell also needs to be present. Once completed, the audit form to be signed by Ray Williams and Commander Puente, and the (3) committee members.

New Business: Commander Puente discussed various committees in need volunteers. He will also bring this up to membership. Membership will be covered by Mike Kotas. But, we have no Color Guard chair or Honor Guard coordinator. Don Reddeman will still chair poppies. We need Honor Walk, and Norm Tibbs accepted. Memorial Day parade, has been headed by Joe Salvia. Education & Scholarship, still open, but Butch Maxwell is interested. Bingo will be Mike McDonnell and Commander Puente. Club Room and Gaming Tickets will be Mike McDonnell. Legion Riders is Paul Kolleda, Director. House & Building is Commander Puente unless other volunteers. The Executive Committee will remain Commander Puente and Adjutant Dobransky.

Closing: Commander Puente made motion to close Executive Committee meeting, First, Merritt, Second, Winder. Voice Vote Passes. There being no further business to come before the Executive Committee the meeting was adjourned at 18:45 with the proper closing ceremonies being observed.
