 - b) Ventilation Improvement (Matheson) – Done
 - c) Sound-deadening Insulation – Done
 - d) Electrical Work (M&D Selected)
 - 1) Removal un-needed wiring – Done
 - 2) Label remaining wiring – Done
 - 3) Install new Wiring – In progress
 - e) Ceiling Tile Installation - (Skyline Builders) – Pending selection of tile color and style.
 - f) Perimeter Wall Repair – Not initiated

Commander Nelson thanked PC Joe Salvia for his hard work on this project.

2) Air Quality in the Post Hall – Discussion was held on renovation of the ventilation and fresh air makeup systems for the Post Hall.

- a) There is no fresh air makeup in the hall area.
- b) Joe Salvia reported that Bob Matheson could install a thermostat controlled fan in the hall. Bob will provide an estimate to help control fresh air in with 5 air cleaning units from the clubroom to remove vents.
- c) Bob Janoska recommended that we wait and see how downstairs works before starting upstairs.
- d) Bob Matheson estimates that the cost of the work in the hall would be between \$6300.00 and \$6800.00.
- e) Mike McDonnell recommends waiting until we have replenished funds before we proceed.
- f) We can ask Mark (Bob Matheson's Son in Law) to assist us with drawings for the project.
