#### **Minutes:**

Adjutant Hoobler presented the minutes of the September 16<sup>th</sup> 2008 Executive Board Meeting and made a motion to accept the minutes. Second was Jack Winder. The motion passed.

#### **Guests:**

### **Guest Presentations:**

A motion was made by J. Salvia to suspend the regular order of business to allow for guest presentations. Seconded by B. Janoska, and passed by voice vote.

• Larry Waligora the Milford Twp Fire Chief presented the plan for improvement of the existing Fire House from its 5000 Sq Ft. facility to a 17000 Sq Ft facility with Offices, Training Room, and Living Quarters. The Training Room converts into an Emergency Operations Center when needed to house Police Operations during an emergency.

- The cost to township property owners will be approximately \$29.00 per \$100,000 of value assessed for 22 years or .293 Mills. This proposal will be on the Nov 4<sup>th</sup> ballot.
- Ouestions:

Bob Janoska – Is there much opposition to this proposal? Chief Waligora – With the economy in the position that it is in there is some opposition but not an extreme amount.

Joe Salvia – Is the cost based upon today's property values? Chief Waligora – The cost is based upon an amortization over 2 years.

Rich Chowaniec – How did you get around the requirement for an elevator to the  $2^{nd}$  floor? Chief Waligora – The  $2^{nd}$  floor area is only available to the Fire Fighters.

Tony Puente – Will you still have to do training in Highland? Chief Waligora – In the past we have sent our Fire Fighters to Boot Camp in Highland. When this is completed the Boot Camp and Fire Academy will move here.

Bob Jamoska – What do you want from the American Legion? Chief Waligora – Your support in the upcoming election for this proposal.

- Joe Salvia presented a motion that the Post recommend approval of the renovations as presented. Second was Lance Oberg. The motion passed. The Adjutant will write a letter to the Township Supervisor addressing the Post support for the renovations.
- The pictures of the renovated Fire House will be posted prominently at the Friday night Bingo.
- Steve Przbylla on behalf of the Milford Fire Department thanked the membership for their support.
